## Maintenance of Discipline and code of conduct among **Students**

- **1.** All students pursuing courses of study in the college Teaching Departments shall observe the code of conduct as may be laid down by the rules and regulations of the college, as notified from time to time.
- **2.** Any violation of the code of conduct or breach of any rule or regulation of the college by any student shall constitute an act of indiscipline and shall make him/her liable for disciplinary action against him/her.
- **3.** The following acts in particular shall constitute acts of gross indiscipline, and any student found indulging in any of them shall render himself/herself liable for disciplinary action against him/her.
- **A.** Disobeying the teacher or misbehaving in the class.
- **B.** Quarrelling or fighting with a college employee or any employee in the canteen, or any other public utility services functioning on the campus or among themselves.
- **C.** Disfiguring or defacing college property by writing slogans or any material obscene in nature, skeletons or figures, on any building or walls (thereof within the campus, which is not authorised by the University administration in any manner whatsoever.
- **D.** Behaving in the college campus or outside in a manner that is indecent or which is meant to annoy or harass the teachers, officers, employees and students of the college.
- **E.** Any other act which the Proctorial Board may determine and the Principal may accept as an act of gross indiscipline or indecency.
