

The noble intentions and objectives of the Youth Parliament programme have been lauded by all quarters, including parliamentarians, academicians, bureaucrats, etc.

As you are aware, the Ministry has introduced the National Youth Parliament Scheme (NYPS) 2.0 (<https://nyps.mpa.gov.in/>) – an upgraded version of the NYPS web-portal. No longer confined to only the students of recognized institutions, the NYPS 2.0, welcomes every citizen to participate in the Youth Parliament Programme of the Ministry. Participation is now possible through the following ways:-

- i. **Institution Participation:** All educational institutions can participate in this category by organising the Youth Parliament sittings as per the guidelines available on the portal. The students from classes VI to XII may be selected for the "Kishore Sabha" sub-category, and Under Graduate and Post Graduate level students may be selected for the "Tarun Sabha" sub- category.
- ii. **Group Participation:** A group of citizens can participate in this category by organising the Youth Parliament sittings as per the guidelines available on the portal.
- iii. **Individual Participation:** An individual citizen can participate in this category by attempting a quiz on the theme of 'Bharatiya Democracy in Action'.

Kindly refer to this Ministry's D.O. letter No. 6/5/2018-YP dated 28th November 2019 addressed to the then Hon'ble Minister of Human Resource Development and letter No. 6/1/2019-YP-Part (2) dated 30th March 2022 addressed to the then Secretary, Department of Higher Education regarding the participation of educational institutions in the 'National Youth Parliament Scheme (NYPS)' of this Ministry (*Copies attached*).

The Ministry of Parliamentary Affairs has been organizing Youth Parliament Competitions since 1966 in various educational institutions of the country in order to strengthen the roots of democracy, inculcate healthy habits of discipline, develop tolerance of divergent views and familiarize the student community with the procedures and functioning of Parliament. The noteworthy objectives of the Youth Parliament programme have been lauded by all quarters including parliamentarians, academicians, school administrators, etc. In the past, many requests have been received to involve more institutions under the programme of the Ministry. Therefore, to increase the coverage under the Youth Parliament Programme of this Ministry to hitherto untouched sections and corners of the country, the Ministry designed a web-portal for the National Youth Parliament Scheme (NYPS) in 2019. The web portal was launched on 26th November, 2019 in Central Hall, Parliament House, New Delhi by the Hon'ble President of India in the august presence of the Hon'ble Prime Minister, other Ministers and Members of both the Houses of Parliament.

At present, the registration for the 4th Edition on the NYPS portal is going on. The web portal allows all the recognized educational institutions of the country to register on the portal and organize youth parliament sittings. The portal can be accessed at <https://nyps.mpa.gov.in/>. The salient features of the web portal are:-

- All recognised educational institutions of the country are eligible to participate in this programme.
- The registration for participation is done by the educational institutions on the web-portal.
- E-training modules, videos, photographs and scripts in connection with Youth Parliament are available on the portal for online self-learning of the participants.

- After successful registration, the educational institutions will be able to conduct youth parliament sittings in their respective institutions.
- Each student taking part in the sitting will get a Digital '*Certificate of Participation*' and the Teachers-in-charge and Head of Institution each will get a '*Certificate of Appreciation*' through the web portal.
- Each institution is allowed to conduct multiple Youth Parliament sittings through separate registrations for separate batches of students.

I would, therefore, request you to issue necessary instructions to all concerned to maximize participation of educational institutions all over the country on the web portal-based National Youth Parliament Scheme (NYPS) of this Ministry on a regular basis.

In addition, various All India Educational Boards and other relevant organisations could be requested for considering participation in the National Youth Parliament Scheme as an extra-curricular activity/project work in Educational Institutions.

Further, you are also requested to provide us the database of the names of the educational institutions and their respective email IDs, which will enable us to send detailed email communications for facilitating their engagement in the web portal-based National Youth Parliament Scheme.
