FEATURES OF PAY ROLL SOFTWARE AT ZAKIR HUSAIN DELHI COLLEGE (EVENING)

1. Pay Roll Software should be multi user and based on 6th CPC and 7th CPC recommendation

2. Salary and Pension Components/ Heads & Some Misc. features

- 2.1. Flexibility to add number of Earning/Deduction Components
- 2.2. Components should be fixed or formula based
- 2.3. Calculations should be based on attendance
- 2.4. Option should be available to hold or freeze salary in case of termination of employee/ dues not clear in case of resignation
- 2.5. Pay Slip should be sent on email id of employees through single click
- 2.6. Pay Slips should be printed for groups or for selected employees
- 2.7. Lock month facility should be available to avoid changes in processed data
- 2.8. Supplementary payment option should be available
- 2.9. Monthly payment register with consolidated summary sheet of earning and deduction components
- 2.10. Yearly payment register of individual employee should be prepared

3. Tax Deduction at Source

- 3.1. Quarterly TDS return of Salary (24Q) should be filled directly from pay roll software without any manual entry in Income Tax Department Portal.
- 3.2. Automatic calculation of TDS on the basis of income and investments
- 3.3. Able to generate TDS projections
- 3.4. Yearly Form 16 should be generated
- 3.5. Any changes in the Income Tax Rule by the Government of India should be implemented without any extra payment

4. Arrears

- 4.1. Arears calculation option should be available for Earning and Deduction heads with filters
- 4.2. Automatic arrear calculations for different periods/fraction of periods/on the basis of attendance
